Kerala Co-operative Milk Marketing Federation Ltd., Central Products Dairy, Punnapra P.O, Alappuzha invites competitive quotations from Kerala legal metrology dept licensed vendors for mechanical structure work of 60MT capacity pit type weigh bridge at Central Products Dairy, Punnapra P.O, Alappuzha subject to the following terms and conditions.

1. SCOPE OF WORK:

Mechanical structure work of 60MT capacity pit type weigh bridge at Central Products Dairy, Punnapra P.O, Alappuzha. The scope of work consists the following:

1. Dismantling of existing weigh bridge platform plates, platform girders, MS flats, Load cells with connections, etc from the existing weigh bridge platform.
2. Supply and fabrication welding and erection of new 3 nos MS Girders with ISMB 400 X 140 x 9000 mm to replace the 3 nos damaged girders.
3. Supply, fabrication, welding and erection of three numbers 12 mm thick plates of size 3100 x 1500 mm to replace the existing three damaged plates.
4. Supply, fabrication welding and erection of MS Flat of size 900 X 20 X 5 mm - 72 Nos as stiffener on MS plate platform.
5. Painting of entire structures, platform, etc after cleaning thoroughly with 2 coat of primer and 2 coat of enamel paint.
6. Re-installation of weighbridge platform completely after repair, fabrication, modification works.
7. Re installation load cells, electronic units, controller, etc. after repair work of weigh bridge mechanical structure.
8. Testing, trial run, calibration and certification of weigh bridge from legal metrology dept, Govt.of Kerala.
9. You shall arrange all statutory formalities with the Legal Metrology Department before commencement & after completion of the work and the original documents/ certificates shall be submitted to us. The weigh bridge shall be calibrated with standard testing equipments/ weights.

2. ELIGIBILITY CRITERIA:

For the purpose of this particular contract, bidder should meet the following qualifying criteria as minimum

- a. The contractor should have valid license from legal metrology dept, Govt of Kerala for executing similar repair works of weigh bridges.
- b. The contractor should have experience in similar works (repair of weigh bridges) for past five years at the time of bid opening. The proof of experience in the form of work orders, completion certificates issued from reputed organizations shall be submitted along with

the bid as documentary evidence. (Minimum 3 work orders/work completion certificates after 01/01/2020)

- c. Offers submitted without qualifying the eligibility criteria (a & b) will be rejected.

3. TERMS AND CONDITIONS:

1. The specification for each item of work and schedule of quantities are given in the enclosed Annexure-1.
2. The rate quoted shall be inclusive of all applicable taxes and duties, ESI contribution, material cost, labour cost, transportation of materials to site, loading and unloading charges and nothing extra will be paid on any account.
3. The unit rates should be quoted both in figures as well as in words. In case of discrepancy in the rate quoted in figures as well as in words, the amount quoted in words shall be taken as final and binding on the party.
4. Based on the unit rates quoted, the total amount for each item of work should be worked out and indicated in the offer. The unit rate quoted should be legible without any erasion /overwriting. In case of any correction and alterations in the unit rates at the time of quoting the same should be signed in full by the quotationer.
5. Quantities indicated in the schedule are only tentative and may vary to the +/- side. However, payment will be made for the actual quantities executed at site as per the directions of Officer in charge, on unit rate basis. No extra claim shall be entertained on this account.
6. The award of work shall be on item rate contract basis and no part of the work shall be considered on percentage or lump sum basis unless specifically agreed by the undersigned.
7. The unit rate quoted should remain firm for the entire duration of contract and nothing extra will be paid on any account.
8. The materials required for the above work shall have to be arranged by the contractor at site.
9. Submission of stamping fees to Legal Metrology Department is in scope of vendor.
10. Rates are inclusive of all taxes (GST etc.), freight, stamping by Legal Metrology Dept, packing & forwarding, loading & unloading etc.
11. The bidder shall quote the rates in the schedule of quantities attached with the Re Tender document only. The bids shall be submitted after signing at the bottom of every page of Re Tender document.

4. VALIDITY:

The offers submitted by the quotationer shall remain valid for acceptance for a period of 60 days from the date of opening.

5. PERIOD OF COMPLETION:

At the items specified in the scope of supply should be completed in all respects within 20 days from the date of receipt of supply order. However, the quotationer after examining the scope of supply and site conditions can specify in the offer the shortest period by which he will complete the supply of items in all respects.

6. SUBMISSION OF BILLS AND PAYMENT:

1. Bills shall be prepared in duplicate in the name of the **Kerala Co-Operative Milk Marketing Federation Ltd, Central Products Dairy, Punnapra P.O, Alappuzha GST: 32AAAK5375M4ZD** and shall be submitted along with the copy of the GST registration, PAN card to the Engineer for necessary certification and recommendation for payment.

2. 90% Payment will be released within 15 days after completion of the above work in all respects, after taking joint measurement for actual quantity of work executed at site and upon submission of stamping certificate from Legal Metrology, Kerala. The Contractor should submit the bill along with the measurement sheets for the works.
3. Balance 10% of contract amount will be released after successful completion of guarantee period of one year from the date of commissioning.

7. SUBMISSION OF QUOTATIONS AND OPENING:

1. The offer must be submitted in original in a sealed cover super scribing the name of the work, due date and time of opening.
2. Bidder should attach this Re Tender document with rates written in the annexure attached along with this Re Tender document, after signing at the bottom of each page of Re Tender document as a token of acceptance of the terms and conditions and specification. The offers submitted in any other formats will not be accepted.
3. The offers complete in all respects should reach this office on or before 1 PM on 20/08/2025 and the same shall be opened at 3 PM on 20/08/2025 in the presence of interested quotationer or their authorized representatives.
4. The bids received after the Re Tender submission date and time will not be accepted. Dairy will not be responsible for any delay in receiving the bids sent through post/courier.

8. GUARANTEE:

1. The supplier shall provide warranty for the items supplied in part or full if found defective due to bad workmanship or substandard materials within 12 months from the date of supply in dairy. The entire expenditure towards replacement / repair shall be borne by the supplier.

9. GENERAL:

1. The undersigned reserves the right to accept any quotation in part or full.
2. The undersigned reserves the right to accept or reject any or all quotations without assigning any reason whatsoever and no explanation can be sought on this account.
3. The purchase order will be allotted to the successful quotationer only on prior approval by the Managing Director, KCMMF LTD.
