1. Nature of work:

Supply and installation of Laboratory Equipments at Cattle Feed Plant, Malampuzha, Palakkad District.

2. Price Basis:

The bidder shall quote their rates in the standard **Quotation Submission Form** provided indicating the breakup details. The quoted rates shall be in Indian Rupee and on FOR basis, inclusive of all taxes, duties, loading charges, transportation to site, unloading charges at site, insurance and all other incidental expenses for the safe delivery of the equipment at site and satisfactory commissioning of the equipment

including imparting necessary training on operation and maintenance to the buyer's representatives.

3. Validity:

The offer should remain valid for acceptance for a period of 90 (Sixty) days from the date of opening of bids

4. Period of completion:

The works shall be completed within in 30 days from the date of receipt of this order.

5. <u>Delivery:</u>

The equipment should be supplied within 30 days from the date of receipt of order in the following address. However early delivery period will be appreciated. In case of failure by supplier in making delivery, within the time specified, the Federation reserves the right to terminate the order, without assigning any reason thereof and the EMD will be forfeited.

7. <u>Payment:</u>

- a. 90% payment after successful supply, installation and commissioning of the equipment.
- b. Final 10% will be released against submission of a bank guarantee for a period of 2 year for an equal value from a Nationalized Bank/Scheduled Bank/New Generation Bank. In case the bank guarantee is not submitted, the 10% payment will be released after the guarantee period of 2 year.

8. Insurance:

The supplier shall arrange insurance coverage according to dispatch instructions issued by the buyer in the name of The Managing Director, KCMMF Ltd., and should cover all dispatches. However, to avoid complication that may arise at the time of settlement of claims by the undertakers for the transit losses, it is proposed that the insurance coverage shall be analyzed by the supplier as under:

- a. Supplier should arrange insurance coverage commencing from their warehouse/works to the factory of the buyer.
- b. The cover provided by the insurance will be in such currency and in such amount so as to allow complete replacement for any item lost or damaged.

9. Guarantee:

The contractor shall guarantee to repair/replace without any extra cost, the items supplied in part or full if found defective due to bad designing, poor workmanship or substandard material within 24 months from the date of completion of supply / commissioning in all respects. The entire expenditure towards replacement/repair shall be borne by supplier.

10. Submission of Quotations and Opening:

The offers should reach this office on or before 14.00 hrs. on 14.08.2025 and will be opened at 15.00 hrs. on the same day in the presence of interested quotationers or their authorized representatives.

11. Delays in the Contractor's Performance:

- 11.1 Delivery of the Goods and performance of services shall be made by the Contractor in accordance with the time schedule specified by the KCMMF LTD in its Schedule of Requirements.
- 11.2 An unexcused delay by the Contractor in the performance of its delivery obligations shall render the Contractor liable to any or all of the following sanctions: forfeiture of its performance security, imposition of liquidated damages and/or termination of the Contract for default.
- 11.3 If any time during performance of the contract, the contractor or its subcontractor(s) should encounter conditions impeding timely delivery of the

Goods and performance of Services, Contractor shall promptly notify KCMMF LTD in writing of the fact of delay, its likely duration and its cause(s). As soon as practicable after receipt of the Contractor's notice, the KCMMF LTD shall evaluate the situation and may at its discretion extend the Contractor's time for performance, in which case the extension shall be ratified by the parties by amendment of the Contract.

12. <u>Liquidated Damages</u>

- 12.1 If the Contractor fails to deliver any or all of the Goods or perform the Services within the time period(s) specified in the Contract, the KCMMF LTD shall, without prejudice to its other remedies under the Contract, deduct from the Contract price, as liquidated damages, a sum equivalent to:
 - I. 0.5% of the full contract value for each week of delay
 - II. The total amount so deducted shall not exceed 5% of the Contract value. Once the maximum is reached, the KCMMF LTD may consider termination of the Contract.

13. <u>Force Majeure:</u>

- 13.1 The Contractor shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- 13.2 For purposes of this clause, "force Majeure" means an event beyond the control of the Contractor and not involving the Contractor's fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts of the KCMMF LTD either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 13.3 If a Force Majeure situation arises, the Contractor shall promptly notify the KCMMF LTD in writing of such condition and the cause thereof. Unless otherwise directed by the KCMMF LTD in writing, the Contractor shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
