QUOTATIONS FOR PACKAGED DRINKING WATER - TERMS & CONDITIONS

- The rate quoted shall include cost of bottles, labels, caps, cap sleeve, shrink sleeves, cartons etc and the Milma logo and other details should be printed on cap, sleeves and cartons. The rate quoted shall be on per carton basis. The number of bottles per carton should be specified. GST should also be specified.
- 2. The rate quoted shall be inclusive of all taxes, packing materials and ex godown basis including loading charges.
- 3. If you have transportation facility, transportation charges may be quoted separately.

- 4. The manufacturer should have license from Bureau of Indian Standards for manufacture of Packaged Drinking water. He shall also have a valid FSSAI License and ISO:22000 certifications.
- 5. The Packaged Drinking Water shall have the quality specification of FSSAI Standard and BIS Standard of IS:14543
- 6. The bottle used for packing shall be food grade quality materials
- 7. The manufacturer should undertake all responsibility for statutory and taxation matters as may be in force from time to time.
- 8. The manufacturer should arrange to load the vehicle arranged by us at their cost.
- 9. Milma will provide the artwork for the labels. However, the manufacturer shall print and procure the labels at their cost. The option of using the bottle of the manufacturer can also be pursued.
- 10. The product shall have six months shelf life from the date of supply and any complaint arising during the period shall be addressed by the manufacturer.
- 11. The rate agreed will remain static for **ONE** year from the date of agreement.
- 12. The manufacturer shall be responsible for all quality defects and necessary replacement shall be made wherever such defects are observed.
- 13. Milma has the authority to reject any quotations without assigning any reason.
- 14. The payment will be released once in 15 days after satisfactory receipt of the material.
- 15. The final decision will be taken only after inspection of the factory by Milma authorities.
- 16. The manufacturer shall enter into an agreement with Milma which shall be in force for a period of one year.
- 17. This agreement can be renewed for further periods if mutually agreed by both the parties.
- 18. The manufacturer shall carry on the manufacturing operations of the "MILMA Packaged Drinking Water" (in 200 ml to 5 liter bottle) at its own cost and using its own

- qualified/experienced personnel, team etc as per the product specification and standards prescribed by "Bureau of Indian Standards" (BIS).
- 19. Manufacturer shall provide a security deposit of Rs.50, 000/- either by cash or by draft of a nationalized/scheduled bank as a guarantee for fulfillment of the agreement.
- **20.** An Earnest Money deposit (EMD) of Rs. 25,000/- shall be remitted by Cash/Demand draft/ NEFT(State Bank of India, Current Account number 67233798063, Pattom Branch, IFSC # SBIN0070212) in favour of Managing Director, KCMMF Ltd, Milma Bhavan, Pattom . The details shall be enclosed along with the offer.
- **21.** The final selection of the manufacturer will not only be based on the rates quoted. A technical committee will inspect the manufacturer's premises to evaluate the credentials and the final approval will be based on this.

WATER BOTTLES SPECIFICATIONS

Parameters Materials	The preform used for the manufacture of PET bottles meant for mineral water. Packing should from high quality plastic granules of food grade supplied by HPCL/Reliance companies only and should meet at the desired specifications when tested by the competent authority by IS no: 12252.
Blow moulding	Blow moulding should be carried out in clean and dust free atmosphere and air used for the blow moulding should be free from impurities and moisture.
Quality of PET bottles	The bottle should be clean, colourless, transparent in appearance, without any smell and odour and extraneous matter, dust particles or any debris.

Note:-

- 1 The tolerance for the dimensions accepted only when the volume of the bottle found accurate.
- 2 The tolerance for the weight of the bottle will be allowed not more than 5%.
- 3 Shall submit food grade certificate for every consignment.
