2. **Material:**

The materials will be kept in bundles of 50 Nos each. The successful quotationer should lift the entire material offered for sale within the time limit specified . The quotationer shall not reject any bags from the lot identified for sale and all of them will be counted for the purpose of sale irrespective of the extent of damage, if any offer for part quantity offered for sale will not be accepted.

3. **Inspection of material:**

Those who wish to inspect the present stock of material can contact the Manager of the Plant on any working day **between 10.00 hrs and 16.00 hrs from 10.02.2020 to 25.02.2020.**

4. **Rates:**

The rate should be quoted per 100 Nos. The rate quoted should be exclusive of GST and should be legible without any erasion/overwriting. GST @5 % should also be remitted along with the value of gunny bags. For out of State sales also, GST @5% shall be remitted. The rate shall be ex-godown of our Factory, (loading charges payable by buyer) and the successful quotationer, if he intends to count the bags, shall also arrange for counting the bags in the presence of out authorized officer.

5. Validity:

The offers submitted by the quotationer shall remain valid for acceptance for a period of 30 (Thirty) days from the date of opening and thereafter for the entire contract period. If any quotationer withdraws his offer before the expiry of validity period the E.M.D deposited by him will be forfeited.

6. Earnest Money Deposit:

6.1 The offer should be accompanied by an E.M.D of **Rs 50,000/- (Rupees Fifty Thousand only)** separately for each quotation. The E.M.D shall be in the form of Demand Draft from any Nationalized Scheduled Bank drawn in favour of the Manager, Cattle Feed Plant KCMMF Ltd payable it S.B.I Pattanakkad or at the factory cash counter can be paid in cash.

6.2 Offers without E.M.D will be rejected.

6.3 The E.M.D of unsuccessful quotationers will be released on acceptance of the order by the successful quotationer. The E.M.D of the successful quotationer will be released only after the completion or the litting of the entire quantity of PP Bags.

7. Submission of Quotations and opening:

7.2 **The quotaions complete in all respects along with E.M.D should reach this office on or before 14.30 hrs on 25.02.2020** Details of E.M.D remitted should be indicated in the quotation at the place provided in the Annexure. The quotations shall be opened at 15.00 hrs on the same day in the presence of the interested quotationers or their authorized representatives.

7.3 The quotationers should quote their rate in the annexure only.

8. Security Deposit:

Successful quotationer should remit a sum of Rs.1,00,000/- (Rupees One lakh only), as security deposit at the Plant by way of Demand Draft drawn in favour of Manager, Cattle Feed Plant Pattanakkad payable at S.B.I Pattanakkad or by cash within 3 days from the date of receipt of the order. The Security Deposit shall be adjusted towards the value of gunnies while taking delivey of the last lot. **If the successful bidder (H1) is not able to remit the said amount of Rs.1,00,000 within 3 days ,then the E.M.D (Rs.50,000) will be forfeited and contract will be awarded to H2 (second highest) without notice. In this case H1 will be black listed from participating further Tenders from CFP Pattanakkad. If H2 is not able to remit security deposit**

Rs.1,00,000/- (One Lakh Only) within 3 days of the receipt of the order, he will also be black listed and the E.M.D amount will be forfeited. In this case the order will be awarded to the H3 (the third highest)

When a party is black listed then he or his firm or a firm having any connection with the said party will not be considered for further tenders in Cattle Feed Plant Pattanakkad.

9. Remittance of sale value:

The successful quotationer should remit the full cost of the material offered for disposal including GST in advanced by way of demand draft of any nationalized bank / scheduled bank drawn in favour of the manger, cattle feed plant, pattanakkad payable at S.B.I, pattanakkad from time. The Payment can also be made by RTGS transfer to SBI Pattanakkad.

10. Delivery Schedule:

The successful quotationer should lift the entire material with in six months from the date of confirmation, at his own cost.

11. General:

a. The Manager, Cattle Feed Plant KCMMF reserve the right to conduct auction. Auction if required will be conducted before opening of the quotations and only after completion of the auction shall the quotations be opened . Only those bidders who have submitted the offers and furnished the E.M.D shall be permitted to take part in the auction. During the auction the quotationers are required to increase the rate by a minimum of 10/- per 100 bags for each auction call. The highest rate quoted, either in the auction or in the tender, will be considered as final. The Manager reserves the right to conduct negotiations with the highest bidder. The finalization of the sale shall be subject to our Head Office approval. The rate may be finalized with more than one party according to the discretion of K.C.M.M.F.Ltd.
