Scope of work:

- We have three nos of DVR located at two areas and the proposed NVR should be able for combine with the existing DVR and all views should be accessible from one location. Also, there should be provision to access the CCTV system from minimum 5 mobiles and it has a provision to access the views from our head office located at Thiruvananthapuram through Network connection.
- The views can be seen as single, tile view, auto sequence, etc
- Presently we have 5 Nos of 2 TB hard discs each connected to 3 DVRs. We have to get minimum One month backup for the new systems for viewing the recorded views in HD format and provision to access the views as and when required.

• The newly installed system should be guaranteed for minimum two year and the software should be available for minimum 10 years.

- 5. The offer should be valid for minimum three months.
- 6. The successful tenderer shall have to complete the work within a period of 15 days from the date of award of work.
- 7. The model has to be inspected and approved by us before acceptance. Also you have submit a warranty certificate along with your invoice for effecting payment.
- 8. The quantities indicated in the schedule are only tentative and may vary to the +/side. However, payment will be made for the actual quantities executed at site on
 unit rate basis.
- 9. An Earnest Money Deposit (EMD) of Rs. 3,000/- shall be remitted either by cash/ NEFT (State Bank Of India, Current Account Number 57036448585, Punnapra, Alappuzha-4, IFSC Code SBIN0070215) in favour of Manager, Central Products Dairy, Alappuzha. The details shall be enclosed along with the offer. The amount shall be returned only after finalization of the tender.
- 10.Payment terms: 95% payment will be released after completion of the works and balance 5% will be release against a bank guarantee for the same amount from a nationalized bank/scheduled/new generation bank. If not will be release only after the guarantee period of 24 months.
- 11. Safety Measures: The contractor shall arrange for all compliance to the ESI/PF rules in force and Central Products Dairy, Punnapra shall not be liable for any benefits/compensation in the event of accident/mishap, injury etc suffered by the workmen engaged by the contractor to provide suitable safety measures to the workers engaged by him.
