## **SCOPE OF WORK:**

Damaged elevator side plate replacement with new painted ms plate with new fasteners, and recondition works at the damaged elevator bottom.

### SCHEDULE OF QUANTITIES AND RATES:

The rate quoted shall be inclusive of all applicable taxes and duties including GST, ESI contribution, material cost, labour cost, transportation of materials to site, loading and unloading charges and nothing extra will be paid on any account.
