Terms and conditions.

- 1. All the works shall be carried out as per the directions of our plant Engineer.
- 2. The materials supplied for tile work shall be of approved make and shall be inspected & approved by our Engineers before acceptance. The Endura terracotta tile of 20 mm thick will be supplied by us.
- 3. You shall arrange for all compliance to the ESI/PF rules in force. Milma Central Products Dairy shall not be liable for any benefits/mishaps, etc. during execution of work. The contractor shall provide suitable safety measures of workers.
- 4. Statutory recoveries like ESI will be deducted from your bill amount.
- 5. You shall provide all the tools & tackles, skilled labour etc for the works.
- 6. All materials/debris/tools/equipments, etc, shall be completely removed from the site as per the instruction of our Maintenance Engineer.
- 7. All the work should be completed in all respects within two weeks from the date of receipt of work order. Any demurrage/detention/penalty charges incurred due to the delay in the completion of the work shall be charged on percentage basis to the Contractor's account.
- 8. The works shall be guaranteed for minimum of six months. Work found inferior in quality/ workmanship on completion shall be redone at contractor's risk and cost.
- 9. All materials/debris/tools/equipments, etc, shall be completely removed from the site as per the instruction of our Maintenance Engineer.

- 10. **Payment terms:** 95% payment will be released after completion of the works and balance 5% will be released against a bank guarantee for the same amount from a nationalized bank/scheduled/new generation bank. If not will be release only after the guarantee period of 6 months.
- 11.Preferably sealed quotations shall reach our office on or before 2.00 P.M on 10.02.2024 and will be opened at 2.30 P.M on the same day.
