SCOPE OF WORK:

The Scope of work also involves cleaning of tank, supply of consumable like brush & tools, skilled labour, scaffolding, epoxy primer, epoxy paint etc. for painting inside of Molasses Tanks at our Cattle feed Plant, Pattanakkad

SCHEDULE OF QUANTITIES AND RATES:

EMD

VALIDITY:

The offers submitted by the quotationer shall remain valid for acceptance for a period of 60 days from the date of opening.

PERIOD OF COMPLETION:

At the works specified in the scope of work should be completed in all respects within 30 days from the date of receipt of work order. However, the quotationer after examining the scope of work and site conditions can specify in the offer the shortest period by which he will complete the above works in all respects.

SUBMISSION OF BILLS AND PAYMENT:

Bill shall be prepaid in duplicate in the name of Manager, Cattle feed plant Pattanakkad and shall be submitted to the HOD (Production) for necessary certification and recommendation for payment.

SUBMISSION OF QUOTATIONS AND OPENING:

The offer must be submitted in original in a sealed cover superscribing the named of the work, due date and time of opening.

The offer should be submit to this office on or before 3 pm hrs. on 20/01/2023 and opening will be on the the same day at 3.30pm.

GENERAL:

- 1. All the equipment and materials like brushes, scaffolding, ladder, tools, safety belts etc. required are to be arranged by the contractor and all safety measures required for the workers engaged shall be taken care of by the contractor.
- 2. The Paint required will be from standard supplier like Berger, Asian ,Nerolac etc. also in contractor's scope.
- 3. The entire work shall be completed within 30 days from the receipt of the work order.
- 4. 90% of the total bill amount will be released within 15days after the entire work completion and submission of original invoices. Balance 10% will release only after the guarantee period of six months.
- 5. Work found inferior in quality / workmanship on completion shall be redone at contractor's risk and cost.
- 6. The contractor shall guarantee to rectify any defect on this work undertaken due to bad workmanship or usage of substandard materials, within six months from the date of completion of the work. An undertaking shall be submitted along with the bill for payment.
- 7. Each item of work shall be approved prior to commencement of the next work.
- 8. The contractor will be permitted to carry out the work only after the receipt of work permit issued by the Manager of the plant. The validity of the permit is one day only. If the work is not completed within a day a fresh permit shall be taken on next day.
- 9. The contractor shall arrange for all compliance to ESI/PF rules in force. Cattle feed plant shall not be liable for any benefits / compensation to the workers engaged by the contractor, in the event of accidents / mishaps etc. during execution of work. The contractor shall provide suitable safety measures to workers.
- 10. The contractor or his workmen shall not interfere in any activity of the plant and /or cause any damages to buildings / property. The entry of all such labourer will be on the basis of gate pass, which will have to be arranged by the contractor prior to starting the work. In the event of any damage to Cattle feed plant's property, the contractor shall provide suitable safety measures to the workers.
- 11. Income tax, work contract tax, ESI on the labour part and other applicable statutory deduction if any shall be effected while settling bills.
- 12. The Manager reserves the right to accept any or reject all the quotations without assigning any reasons

The sealed quotation shall reach our office on or before 3pm on 20/01/2023 and will opened on the same day at 3.30pm.
