Sub: Enquiry for removal of trees, plants, grass, bushes etc. within the plant premises of Cattle feed plant, Pattanakkad - reg.

Quotations are invited from individuals/contractors/institutions for the cutting of trees, plants, bushes, grass within in plant premises of Cattle feed plant, Pattanakkad. Scrap materials that can be shifted manually found if any must be shifted to the designated place as per instruction of shift engineers.

SCOPE OF WORK:

The scope of work involves removing the unwanted trees, plants, bushes, grass etc. By manually/suitable machinery to keep the plant area clean and tidy. Scrap materials that can be shifted manually found if any must be shifted to the designated place as per instruction of shift engineers.

SCHEDULE OF QUANTITIES AND RATES:

The specification of the work and measurements of the area to be cleared are given in the enclosed Annexure -1.

The unit rates should be quoted both in figures as well as in words. In case of discrepancy in the rate quoted in figures and in words, the amount quoted in words shall be taken as final and binding on the party.

The unit rates quoted should be legible without any erasion /overwriting. In case of any correction and alterations in the unit rates at the time of quoting the same should be signed in full by the quotationer.

However, payment will be made for the actual quantities executed at site as per the directions of Engineer in charge. No extra claim shall be entertained on this account.

The unit rate quoted should remain firm for the entire duration of contract and nothing extra will be paid on any account.

VALIDITY:

The offers submitted by the quotationer shall remain valid for acceptance for a period of 30 days from the date of opening.

SUBMISSION OF QUOTATIONS AND OPENING:

The offer must be submitted in original in preferably sealed cover superscribing the named of the work, due date and time of opening.

The offer should be submit to this office on or before 01:00pm on 23/06/2022 and the same shall be opened at 02:30 pm.on the same day.

GENERAL CONDITIONS:

- 1. All materials like tools and tackles required are to be arranged by the contractor and all safety measures required shall be taken care of by the contractor.
- 2. The entire work shall be completed within 15 days from the date of receipt of the work order.
- 3. Work found inferior in quality/workmanship on completion shall be redone at contractor,s risk and cost.
- 4. The contractor will be permitted to carry out the work only after the receipt of work permit issued by our Shift Engineer. The validity of the permit is for one day only; if the work is not completed within a day a fresh permit shall be taken on next day.
- 5. The contractor shall arrange for all compliance to the ESI/PF rules in force. Cattle Feed Plant shall not be liable for any benefits/compensation to the workers engaged by the contractor, in the event of accidents/mishaps etc. during execution of work.
- 6. The contractor or his workmen shall not interfere in any activity of the plant and/or cause any damage to buildings/property. The entry of all such labour will be on the basis of gate pass, which will have to be arranged by the contractor prior to starting the work. In the event of any damage to Cattle Feed Plant's property, the contractor alone shall be liable.
- 7. Applicable statuatory deductions if any shall be effected while settling bills
- 8. The Manager reserves all the right to accept any or reject all the quotations without assigning any reasons.
- 9. Payment will be made to the actual quantity of work done but not more than the amount quoted. Nothing will be paid extra.

10. 100% payment will provide only after the satisfactory completion of work
