Sub: Enquiry for supply and installation of water softener.
Please furnish your lowest rate for the supply and installation of following item.

Scope of work

1. Supply and installation of water softening plant of capacity 3KL/hr at our boiler section.
2. The rate includes supply of water pumps, pipe lines, valves, water flow meter, NRV, resin, etc required for the water softner plant.
3. The civil works, inlet and outlet water line, electrification works for the water pumps shall be carry out by us.
4. Need to provide two sample cock in the water softening plant one at inlet and other at outlet.
5. The water softener should be warranty for one year and the softener resin should be warrantee for three years.
6. The hardness of feed water may be vary from 50 PPM to 200 PPM and we have to get the hardness below 5 PPM from softener.
7. The supplier should submit two copies of the drawing, operation and maintenance manual of the water softner plant.

Terms and conditions.

1. The rate quoted should be inclusive of GST and the party should furnish the GST number in their quotation.
2. The cost of water softner quoted as FOR site basis inclusive of GST, P&F, transportation charges, loading and unloading charges, etc.
3. The offer should be valid for minimum three months.
4. All the works shall be carried out as per the directions of our Plant Engineer.
5. All materials/debris/tools/equipments, etc, shall be completely removed from the site as per the instruction of our Maintenance Engineer.
6. All the work should be completed in all respects within 20 days from the date of receipt of work order.
7. An Earnest Money Deposit (EMD) of Rs. 2,000/- shall be remitted either by cash/ NEFT (State Bank Of India, Current Account Number 57036448585, Punnapra, Alappuzha-4, IFSC Code SBIN0070215) in favour of Manager, Central Products Dairy, Alappuzha. The details shall be enclosed along with the offer. The amount shall be returned only after finalization of the tender.
8. Payment: 90% payment will be released after satisfactory receipt of material at site and submission of warranty certificate. 5% after installation of the same and remaining 5% will be release against a bank guarantee for the same amount from a nationalized bank/scheduled/new generation bank. If not will release only after the guarantee period of 12 months from the date of commissioning.
9. **Safety Measures** : The contractor shall arrange for all compliance to the ESI/PF rules in force and Central Products Dairy, Punnapra shall not be liable for any benefits/compensation in the event of accident/mishap, injury etc suffered by the workmen engaged by the contractor to provide suitable safety measures to the workers engaged by him. It will be the contractor's responsibility to meet all the claims for compensation under Workmen Compensation Act, ESI or under any law in respect of the above.
10. Preferably sealed quotations shall reach our office on or before **2.00 P.M** on **02.03.2022** and will be opened at **4.00 P.M** on the same day.
