TERMS & CONDITIONS

1. Bid Security (Earnest Money Deposit):

- a. The Bidder shall furnish, as part of its bid, bid security for the amount as specified in the tender through **in the form of Demand Daft drawn in favour of Managing Director, ERCMPU Ltd.** payable at Edappally. The EMD can also be remitted by cash at our Head office from 10 am to 3 pm during working days and the receipt number should be mentioned in the submitted tender. The tender without EMD will be summarily rejected. Those who have submitted EMD against tender notice no. EU/PUR/4/2023-24/616, dated 10.02.2024 are exempted from EMD.
- b. The bid security is required to protect the ERCMPU against the risk of Bidder's conduct, which would warrant the security's forfeiture.
- c. No interest shall be paid by ERCMPU on the bid security furnished by the bidder.
- d. The bid security may be forfeited if a Bidder withdraws his bid during the period of bid validity specified by the Bidder on the Bid Form; or in the case of successful Bidder, if the Bidder fails:
 - I. To sign the Contract
 - II. To deliver the items in stipulated time

2. Eligibility Criteria.

The Bidder shall furnish, as part of its bid, documents establishing the Bidder's eligibility to bid and its qualification to perform the Contract if its bid is accepted. For the purpose of this, bidder shall meet the following qualification criteria as a minimum.

- a. Bidder should have sufficient experience in the relevant field
- b. The bidder shall furnish copy of GST registration certificate.
- c. Proof of the above should be submitted along with the tender-sealed and signed by bidder, failure of which will lead to disqualification of the bidder.
- d. **Sample submission**: The bidder should submit sample of quoted item at ERCMPU Ltd., Head Office, Edappally on or before critical date. Bid -without submission of sample/ late submission of sample/ samples which non-compliance of technical specifications in this tender will be rejected. Those who have submitted samples against tender notice no. EU/PUR/4 /2023-24/616, dated 10.02.2024 are exempted from sample submission if there is no change in offered item/sample.

3. Documents for submitting tender

- a. Copy of purchase orders/Work completion certificate/GST invoices
- b. Copy of GST registration
- c. This tender document sealed & signed by the bidder along with EMD specified in this tender notice
- d. Price schedule/price offer by the bidder in their letter head. Tender reference No. shall be mentioned in the same.(Price bid Format is attached as Annexure I)

4. Price basis:

The rate quoted should include all expenses for Supply of Garden umbrella including taxes, transportation charges incurred until the delivery of items to various sites under ERCMPU Ltd. unloading charges etc. No any incidental expenses will be allowed. The price shall be quoted in bidder's letter head as per the attached price bid format.

5. Validity

The offer should remain valid for acceptance for a period of 6 (Six) months from the date of opening of bids. The prices finalized for the items coming under contract are fixed for the validity of contract period.



6. Criteria for award of contract:

The ERCMPU will award the contract to the Bidder whose tender has been determined to be substantially responsive to the tendering documents and who has offered the lowest evaluated price, provided that the Bidder has the required infrastructure, capability & the resources to carry out the contract effectively.

7. Guarantee:

The Supplier shall have to guarantee the quality of goods supplied strictly as per specification of contract/purchase order for a period of 1 year.

8. Artwork

The art work for Garden Umbrella shall be supplied by us. You have to contact the concerned section for the artwork after the receipt of Purchase Order.

9. Payment terms

100% payment will be made from concerned office within 20 days after successful completion of supply, on submission of original invoice and recommendation from concerned department.

10. Delivery And Completion Period

The material shall be delivered on door delivery basis including unloading charges to our units within 20 days from the date of order. The material shall be packed with securely standard moisture proof pack. The goods dispatched under the contract on FOR destination basis shall be fully insured against loss or damage in transit at Supplier's A/c.

11. Agreement

Successful bidder should execute an agreement within 7 days from the date of purchase order in non-judicial stamp paper (Kerala) worth ₹ 200/- for satisfactory completion of work. shall obtain membership with ERCMPU by paying a nominal membership fee of Rs. 90.00.

12. Note to Bidders:

- a. All the documents enclosing with the tender should contain the signature and the office seal of the bidder/authorized persons.
- b. ERCMPU does not bind itself to accept the lowest offer and reserve the right to accept any offer without assigning any reason. The bidders shall not have any claim in this regard.
- c. Bidder should have sufficient experience in the relevant field. The work will be awarded based on their previous experience, inspection of previous work, credentials received from other clients of bidders, etc.

15. Liquidated Damage Clause:

If the supplier fails to deliver any or all of the goods or perform the contract within the time period specified in the contract, ERCMPU Ltd shall without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to

- a. 0.5 % of the unexecuted contract value for each week of delay. The total amount so deducted shall not exceed 5% of the contract value. Once the maximum is reached, we may consider the termination of the contract.
- b. Any incidental taxes and levies on account of delay in performance of the contract by the supplier shall be at his account.

However genuine reasons if any will be given due consideration, on production of documentary evidence before operating the liquidated damages clause.

16. Arbitration & Jurisdiction:

- a. In case of disputes arising out of this tender, an arbitrator as mutually acceptable to the supplier and union will be appointed by the Managing Director, ERCMPU Ltd. The arbitrator's decision shall be final, conclusive and binding on both the parties.
- b. In case if either supplier to the tender is aggrieved by the award of the arbitrator so appointed as per clause above or otherwise, they can appeal to Court. The court situated in Ernakulam alone shall have jurisdiction to entertain such disputes.

17. Deviation Statement:

Non-compliance with even a minor technical requirement, terms and conditions should be specifically stated by the bidders in the technical deviation statement to be submitted along with the bid.

18. Managing Director, ERCMPU reserves the right to cancel or reject or accept or withdraw or extend the tender in full or part, as the case may be, without assigning any reason thereof. Any offer containing incorrect and incomplete information shall be liable for rejection. The Ernakulam Regional Cooperative Milk Producers Union Ltd. will not be responsible for any kind of courier/postal delay.
