## **General Tender Terms and Conditions for e-Procurement**

This tender is an E-Tender and is being published online for the custom packing of **RTS fruit drink( Milma Mango Refresh )in tetra /sig packing- for 180/200 ml and for 1000 ml and 500 ml Bottles** FOR Delivary at Milma, Central Products Dairy, Punnapra, Alappuzha. The tender is invited in two cover system from the registered and eligible firms or through individuals through e-procurement portal of Government of Kerala (<u>https://www.etenders.kerala.gov.in</u>). Prospective bidders willing to participate in this tender shall necessarily register themselves with above mentioned e- procurement portal.

The tender timeline is available in the critical date section of this tender published in <u>www.etenders.kerala.gov.in.</u>

## A). Online Bidder registration process:

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on <u>www.cca.gov.in</u>. Once, the DSC is obtained, bidders have to register on <u>www.etenders.kerala.gov.in</u> website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

## **B). Online Tender Process:**

The tender process shall consist of the following stages:

- i. **Downloading of tender document**: Tender document will be available for free download on <u>www.etenders.kerala.gov.in.</u> However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. **Pre-bid meeting**: No pre-bid meeting for this tender.
- iii. **Publishing of Corrigendum**: All corrigendum shall be published on <u>www.etenders.kerala.gov.in</u> and shall not be available elsewhere.

- iv. Bid submission: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document (clause No.3, Instruction to Bidders) of www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- v. Opening of Technical Bid and Bidder short-listing: The technical bids will be opened, evaluated and shortlisted as per the eligibility and technical qualifications. All documents in support of technical qualifications shall be submitted (online). Failure to submit the documents online will attract disqualification. Bids shortlisted by this process will be taken up for opening the financial bid.

#### **Eligibility and qualification requirements**.

- 1.1 To be eligible for the award of Contract, bidders shall provide satisfactory evidence to the Kerala Co-operative Milk Marketing Federation Limited regarding their eligibility, capacity, quality and adequacy of resources to carry out the contract effectively. To this end, all bids submitted shall include the following information.
- a) Copies of original document defining the constitution or legal status, place of registration and principal place of business of the company or firm or partnership or if a joint venture, of each party there to constituting the bidder.
- b) The Bidder should be in the field of Packing of RTS FRUIT DRINK IN (TETRA /SIG PACKING FOR 180/200 ML AND/ OR HOT FILL PET BOTTLES 1000 ML &500 ML) for the past three years.
- c) The bidder should have a valid FSSAI License and ISO: 2180/2000 certification.
- d) The bidder should submit Mango Juice analysis report and food grade certificate from NABL accredited Laboratory.
- e) The bidder shall submit the certificate of authorized agency as a proof of using approved, food grade, fssai compliant material only for production.

- f) The bidder should have the capacity to supply minimum 1,50,000 pkts TETRA /SIG /Month and 12000 hot fill bottles for 500 ml mango juice and 6000 hot fill bottles for 1000 ml per month.
- g) Failure of submission of related documents on the above requirements will lead to disqualification of the tender.

- 1. The rate quoted shall include cost of Laminate, Paper Straw, tray, Bottle, cap, carton, sleeve and Milma logo and other details should be printed on juice sleeve /Laminate and tray. The **rate** quoted shall be **on per packet /bottle basis**. The number of packets in one tray /bottles in one carton for 1000 ml and 500 ml should be specified.GST should also be specified.
- 2. The rate quoted shall be inclusive of all taxes, Packing materials ,Paper straw /carton on FOR Central Products Dairy, Alappuzha basis.

- 3. The manufacturer should have a valid FSSAI license and ISO 2180/2000 certification.

- **7. Recipe and Process Flow Chart :** By Mutual Discussion with Milma, KCMMF Ltd. Central Products Dairy, Punnapra, Alappuzha.
- 8. Testing: The Mango Juice shall be tested at Manufacturing Unit to check the quality norms as per FSSAI standards and as per the requirement of Milma, prior to its final packing and such test reports shall be preserved and will be accessible to Milma as & when required. Certificate of Analysis (COA) needs to be issued by internal labs of manufacturer & which will be further confirmed by Milma officials. Finished Goods will be dispatched only after completion of COA & tests performed by manufacturer and after confirmation of the same with Milma officials.
- 9. **Homogenization:** Manufacturer shall be responsible for homogenization of the mango juice.

- 10.**Packaging:** Manufacturer shall pack the tested Mango Juice 180/200 ml in tetra /SIG packing and in Hot Fill Pet bottles -1000 ml /500 ml as decided by Milma.
- 11. The packing material and other required materials may be arranged by the manufacturer. Laminate should be purchased by the manufacturer and the cost of laminate will be paid by us against proforma invoice from Tetrapack /SIG India Ltd.
- 12. The packing material (HOT FILL PET BOTTLES) and other required materials( CAP/SLEEVES/CARTON) may be arranged by the manufacturer and the rate quoted per bottle of 1000 ml / 500 ml juice shall be inclusive of the cost of the materials .
- 13. While quoting the rate 1% product/ packing material loss may be also be included in the total cost.
- 14.**Storage:** Manufacturer shall be responsible to store the Products at an ambient temperature in a hygienic surrounding/condition as directed by Milma.
- **15.Dispatch & Transportation:** Manufacturer shall be responsible for timely dispatch and Transportation of products **including transit insurance** from the Manufacturing unit to CPD, Punnapra, Alappuzha.
- 16.Manufacturer shall be responsible for all statutory and taxation matters as may be in force from time to time with respect to the products such as Food Safety and Standards Act.
- 17.Weight and measures Act, Sales tax, Excise, Octroi, Insurance etc. All licenses and permissions required under the statutory and Taxation matters shall be obtained by manufacturer.
- 18. The manufacturer shall supply the product as per the PO given on monthly basis.
- 19.Lead time: 10 days from the date of receipt of PO.
- 20. The manufacturer shall be responsible for all quality defects and necessary replacements shall be made wherever such defects are observed.
- 21. The final decision will be taken only after inspection of the factory by Milma officials.

- **25.**Payment terms for Mango Juice Filled in Hot Fill PET Bottles:-50 % advance payment against proforma invoice for the indented quantity and remaining 50% will be released after 30 days from the satisfactory receipt of product at CPD,Alappuzha.
