Sealed Quotations are invited from experienced roofing contractors/individuals for the roofing works at our Cattle Feed Plant Pattanakkad.

Scope of work

The scope of work involves supply of skilled labour, tools etc for changing of roofing sheets (Indalium plus galvalume make with ISI grade) of generator room (incl. supply of materials and installation) at our Cattle feed Plant, Pattanakkad.

Schedule of quantity.

The specification for each of work and scheduled of quantity is given in the enclosed annexure.

PRICE

Prices and charges quoted shall be firm and fixed during the entire period of contract and shall not be subject to any variation or escalation whatsoever on any account.

General Conditions

- 1. All materials including scaffolding, ladder, tools, safety belts etc. required are to be arranged by the contractor and all safety measures required for the workers engaged shall be taken care of by the contractor.
- 2. The entire work shall be completed within 15 days from the date of receipt of the work order.
- 3. Work found inferior in quality/workmanship on completion shall be redone at contractor's risk and cost.
- 4. The contractor shall guarantee to rectify any defect on this work undertaken due to bad workmanship within six months from the date of completion of the work. An undertaking shall be submitted along with the bill for payment.
- 5. Each item of work shall be approved prior to commencement of the next work.
- 6. The contractor will be permitted to carry out the work only after the receipt of work permit issued by our Maintenance Engineer. The validity of the permit is one day only; if the work is not completed within a day a fresh permit shall be taken on next day.
- 7. The contractor shall arrange for all compliance to the ESI/PF rules in force. Cattle Feed Plant shall not be liable for any benefits/compensation to the workers engaged by the contractor, in the event of accidents/mishaps etc. during execution of work. The contractor shall provide suitable safety measures to Workers.
- 8. The contractor or his workmen shall not interfere in any activity of the Plant and/or cause any damages to buildings/property. The entry of all such laborers will be on the basis of gate pass, which will have to be

arranged by the Contractor prior to starting the work. In the event of any damage to Cattle Feed Plant's property, the contractor alone shall be liable.

9. Applicable statutory deductions if any shall be effected while settling bills.
