Sealed price quotations are invited from experienced Mechanical Fabrication Contractors for the following repair and rectification works at Milma, Cattle Feed Plant, Malampuzha, Palakkad – 678651, KERALA.

I. DESCRIPTION OF WORKS:

II. GENERAL TERMS AND CONDITIONS:

1. Applicable statutory deductions like GST, income tax, sales tax, EPF/ESI, Work contract tax, etc. shall be effected while settling bills. The contractors must remit ESI/EPF for the work and for their employees should produce proof of remittance to avoid the ESI cutting while submitting the bills. Submit the challan as the proof of remittance along with bills, for considering release of payment. Without the ESI/EPF remittance proof, payments will be released only after recovering the statutory ESI/EPF from the respective bills.

All essential materials MS or SS Sheets, MS Angles and MS or SS Flat etc. required for

the work shall be brought to the site before commencing the work.

3. Specifications shall be as mentioned in the schedule of work quantities. In case for clarification, our Engineer shall be contacted before taking up the particular work.

4. The quantities and items of works mentioned in the schedule are tentative. Manager reserves the right to place work order for part of the schedule, depending upon the financial implications. Payment shall be effected only for those quantities actually executed at site.

5. The materials shall be inspected by our engineers before acceptance. The materials

shall be of our approved make as per the schedule.

6. Each item of work shall be approved prior to commencement of the next work.

7. The contractor shall arrange for all compliance to the ESI/PF rules in force. Cattle Feed Plant shall not be liable for any benefits/compensation to the workers engaged by the contractor, in the event of accidents/mishaps etc. during execution of work. The contractor shall provide suitable safety measures to their Workers and also the plant raw materials stored in that area in case of any emergency like rain/ wind etc..

8. The contractor or his workmen shall not interfere in any activity of the Plant and/or cause any damages to buildings/property. The entry of all such labourers will be on the basis of gate pass, which will have to be arranged by the Contractor prior to starting the work. In the event of any damage to Cattle Feed Plant's property, the contractor

alone shall be liable.

9. Income tax, ESI and other applicable statutory deductions shall be mandatorily effected while settling bills.

10. The plant day to day activities should not be affected during the course of work.


11. The work done if found to be inferior in quality or reveals bad workmanship, the same shall be redone at contractor's risk and cost.

12. Your price quotation shall include Transportation charges, Labour charges, Material cost, Loading / Unloading charges and Other incidental expenses if any. So nothing extra will be paid apart from the quoted rate later.

III. OTHER TERMS & CONDITIONS:

1. The fabrication contractor shall provide all the fabrication materials and consumables, nuts, bolt, packing material, welding rods, Emery cloth, painting materials etc. required for the works.

2. The fabrication contractor shall bring the tools and tackles required for the works.



4. All the works shall be carried out as per the directions of our plant engineer.

5. The contractor shall guarantee to rectify any defect noticed in works due to bad workmanship within six months from the date of completion of the work.

6. All safety measures shall be taken for the work like including safety belts, scaffolding's etc. Work permit shall be taken before the commencement of work. All risk shall be covered by contractor as per norms.

8. Any legal disputes* regarding the job order execution shall be under the Palakkad jurisdiction.
