#### QUOTATION NOTICE

Sub: Inviting sealed competitive price quotations for the sale of 50 numbers of old Non-BLDC fans

Kerala Co-Operative Milk Marketing Federation Limited (MILMA), Cattle Feed Plant, Malampuzha, Palakkad - 678651, invites sealed competitive quotations for the sale of 50 old ceiling fans. Bidders must offer the shortest possible delivery period as per the technical specifications and schedule of quantities in the enclosed Annexure. All bids are subject to and binding under the following terms and conditions.

#### I. General Terms & Conditions:

1. PRICE BASIS:

All bids must be quoted on an "As-Is, Where-Is" basis at the Cattle Feed Plant, Malampuzha. The quoted price shall be inclusive of all taxes (including GST), loading, and all other incidental charges for the removal of the items from our premises. The bidder is solely responsible for the dismantling, packing, and transportation of the items.

2. PRICE VALIDITY:

The quoted price shall remain firm and valid for acceptance for a period of **90 Days** (**3 Months**) from the bid opening date. Any offer with a shorter validity period may be rejected.

ITEM CONDITION & INSPECTION:

The items offered for sale are used/second-hand and are sold in their present "As-Is" condition, with all faults and imperfections. Bidders are strongly advised to inspect the items physically at their own expense and satisfy themselves regarding the condition, quantity, and specifications before submitting their bids. No complaint or claim in this regard will be entertained after the sale. The items can be inspected at cattle feed plant-Malampuzha during office hours on working days.

4. PAYMENT MODE:

The successful bidder shall be required to make 100% payment against the provisional sale order/invoice



within **7 days** of its issuance. No removal of items will be permitted before payment is cleared.

5. DELIVERY & REMOVAL:

The successful bidder must remove all purchased items from the selier's premises at Malampuzha, Palakkad within 15 days from the date of issuance of the final sale release order. The bidder is responsible for all arrangements and costs related to dismantling, loading, and transportation. The Federation reserves the right to terminate the sale order and further proceedings if the items are not removed within the stipulated period. The risk of loss or damage to the items shall hald with her

6. RISK & TITLE:

The risk of loss or damage to the items shall held with buyer upon payment and the issuance of the sale release order.

6. LIQUIDATED DAMAGES

CLAUSE:

If the successful bidder fails to remove the purchased items within the stipulated removal period, liquidated damages will be levied at 1% of the total sale value per week, subject to a maximum of 5% of the total value. The Federation reserves the right to cancel the sale order and further proceedings in case of such delay.

## II. Specific Terms & Conditions:

- 1. **Essential Documents:** The bidder shall furnish the following details/documents (as copy) for becoming eligible to technically qualify in the bid
  - a. Name of the Bidder / Enterprise entitled to supply
  - b. Company Registration certificatec. Address proof of the Enterprise
  - d. Valid ID proof of the Bidder (such as Adhar)
  - e. PAN copy
  - f. GST registration certificate copy (if registered)
- 2. Rates shall be quoted only in Indian Rupees. Rates shall be fixed during the entire validity period and Price quotations with dynamic pricing and including any other conditional clauses will be summarily rejected.
- 3. **Right of Acceptance:** The undersigned reserves the right to accept the offer either in full or in part, or to reject it entirely, without assigning any reason.
- 4. **Bid Opening:** Only sealed quotations received by postal are valid and considered for evaluation. Open quotations submitted in hand or sent by email will be treated non-responsive and will be totally rejected. Hence the bidders are requested to send their valuable sealed quotations by postal well in advance before the date of opening. Sealed quotations shall reach our office on or before 3:00 PM of **05.12.2025** and the received quotations will be opened on the same day at 3.30 PM in the presence of bidders if any available. Quotations received after 3:00 PM will be rejected.
- 5. **Bidder Confirmation:** Technically qualified bids will only be considered for financial evaluation. Price bids will be assessed in accordance with the Highest Cost Based Selection System. All the bids will be evaluated on the basis of the eligibility criteria through verification of all the essential documents submitted along with the terms & conditions complied by bidder. Though the H1 bidder will be the preferred bidder, simply quoting of highest rate does not confer any right for selection of the bidder at the rate quoted.

KCMMF reserves the right to confirm and finalize the bidder. Quoting of same rates (H1 only) by more than one bidder could be construed as an exceptional circumstance. In such cases, all the bidders who have quoted the same highest rates shall be called for and one more chance will be given for on spot quoting if bidders are present or negotiated quote may be collected via mail with a closing time for rate finalization. If the negotiated quotes are still the same, KCMMF reserves the right to award the sale order equally between the concerned vendors at its discretion.
