1. Invitation of Retender for E-tender

We have started the migration process of other applications and use open source platforms (Linux, Apache, Php, Laravel and PostgreSQL) based applications on the cloud. KCMMF has a long tradition of developing systems in-house and has been doing so since 1980s and will be continuing to do so. At this point we require a service provider to take care of hosting the applications on the cloud and provide system administration services in day to day management of the systems.
