- 4. All the works shall be carried out as per the directions of our plant engineer.
- 5. You will be permitted to carry out the work only after the receipt of work permit issued by our Maintenance Engineer. The validity of the permit is one day only, if the work is not completed within a day a fresh permit shall be taken on next day.
- 6 Work contract tax, E.S.I contribution and other statutory recoveries if any be deducted from your bill.
- The contractor shall guarantee to rectify any defects noticed in your works due to bad workmanship within 6 months from the date of completion of the work.. An undertaking in this regard shall be submitted along with the your invoice for effecting payment.
